An email was received and considered from Carillion with regard to the possibility of an earlier closure time for the above whilst undertaking the re-surfacing.

Council were advised that residents adjoining the A449 had been asked if they would object to the M6 closures commencing at 9.00 pm with the majority advising that they would be in favour. The residents asked if the matrix and speed signs could be move further out of the village.

Councillors voted on the proposal that the M6 closures commence at 9.00 pm with 5 votes for, 2 against and 2 abstentions.

Resolved that:

- [i] Carillion be advised that Councillors voted on the earlier closure with the majority for the change to 9.00 pm, but it was not unanimous and that this decision may not reflect the thoughts of the whole Community.
- [ii] Councillor asked if the matrix and speed signs could be move further out of the village.
