An email was received dated 29th September from SSC Licensing Officer who advised of a Premises License application from Pillaton Garden Centre and Tea Rooms.

3077. HIGHWAY LIAISON GROUP MATTERS

Resolved that:

- [i] A copy of the Schedule be forwarded to SCC Highways at Gailey
- [ii] Councillors to report incidents to the PA which would be included on the Schedule and monitored.
- [b] Consideration was given to if the Council wished to approach the Stafford and Surrounds Clinical Commissioning Group with regard to the impact the Lyne Hill development would have on the village.

Cllr Mrs Viv Smith advised that a Parishioner had sent a letter to the MP with regard to the medical provision and the impact the additional Lyne Hill development would have on the Doctors Surgery. A copy of the letter and the MP's reply was passed to the PA for information.

Resolved that:

- [i] Letters be sent to both the Stafford and Surrounds CCG and MP putting forward Councillors' concerns the new development would have on the Doctors Surgery.
- [ii] A letter be sent to the Doctors Surgery and the Patient Link asking if they had concerns with regard to the impact the Lyne Hill Development would have on the surgery.
- [c] Cllr Eastwood's verbal report on the Cycle Path on the A449 between Rodbaston and Gailey Island was received. He reported that SCC Highways proposed to cease maintenance of the cycle path.

 Resolved that a letter be sent to SCC Highways stating that the Council opposes their decision to cease maintaining the above and consider this to be a retrograde step.
- [d] An email was received from a resident with regard to the difficulty crossing Wolgarston Way due to the height of the plants on the island making visibility extremely difficult. This item to be included on the Schedule [3077a].
