3169. <u>PENKRIDGE LIBRARY</u>

Consideration was given to the provision and future of the Library Services and the use of the additional space within the building.

Cllr Eastwood said that further to the Councillors' Library visit earlier in the year it was thought that the additional space etc within the building could be put to better use. He advised that the Civic Society wished to join with the Friends of Penkridge Library and Parish Council in promoting the historic aspects of the building to the Community. He said that the Friends of Penkridge Library had made him aware of the lack of adequate support for the Library Staff which may lead to some of the services eventually dying off. He suggested that a regular item be placed on the Recreation and Amenities Agenda where the Friends of Penkridge Library could give updates etc to the Parish Council. He also proposed that a letter be sent to SCC asking if the Cells could be opened up and how the Parish Council could get involved with the promotion of the Library and its services. SCC Representatives also be invited to discuss how the building and services could be promoted, together with the Civic Society and Friends of Penkridge Library. Cllr Mrs Ford asked that SCC also confirm what Mobile Library provision there was in the area and the rota it followed.

Resolved that:

- [i] The Library be placed on the Recreation and Amenities Agenda on a regular basis.
- [ii] A letter be sent to the SCC asking if the Cells could be opened up and how the Parish Council could get involved with the promotion of the Library and its services.
- [iii] Representatives of SCC be invited to discuss how the building and services could be promoted, together with the Civic Society and Friends of Penkridge Library.
- [iv] SCC to confirm what Mobile Library provision there was in the area and the rota it followed.

3158. PUBLIC PARTICIPATION

Claire Geoghegan from the Friends of Penkridge Library asked if the Council had received notification from Staffordshire County Council that the Cabinet had agreed to remove all the Mobile Libraries in the Area and if so would they be responding.

The Vice-Chairman advised that there was an item on the Agenda for a discussion on the Library and Councillors had also received a copy of the SPCA Bulletin for the 5th November on the Final Proposal for Staffordshire's Mobile and Travelling Library Service and this could be incorporated into their discussion.

Mr Peter Jones of The Saplings asked if the Council knew the situation with regard to the Lynehill Development, what had been proposed and if agreed when work would commence. The Vice-Chairman advised that there had been an application submitted for 50 houses, 14 of

which would be affordable, and if planning permission were granted they understood work would commence towards the end of January 2016.
