#### **Public Session**

#### 1193. APOLOGIES

An apology was received from Cllr Mrs Hilary Hughes.

## 1194. DECLARATIONS OF INTEREST

There were no declarations of interest.

#### 1195. MINUTES

## 1197. INCOME AND EXPENDITURE

The printouts for the year to date were received and noted.

# 1198. HANGING BASKETS/CHRISTMAS TREE BRACKETS

A quotation was received and considered from Penkridge TV and Electrical to remove the old brackets and replace with the new brackets in Market Street and Crown Bridge at a cost of £450.

**Resolved** that the quotation be approved and the Contractor be asked to only use the manufacturers recommended fixings for the brackets.

#### 1199. A449 BOUNDARY HEDGE - GAILEY TO RODBASTON

- [a] Consideration was given to an email dated 12<sup>th</sup> February from the SCC Community Infrastructure Liaison Manager together with the Chairman's update further to the site visit on 10<sup>th</sup> March.
  - The Chairman advised that the SCC Community Infrastructure Liaison Manager would walk the path and, subject to his report and the provision of the Contractor's Public Liability Insurance, work could go ahead. He said that the hedge was to be cut with hand machinery only and this would not cause any disturbance to the nesting wildlife.
- [b] A quotation was received and considered from Matthew Bissell to cut back the hedgerow along the A449 opposite the Rodbaston Entrance to Dobbies Boundary in order that the public footpath can be used.

The Chairman advised that the Committee should wait for the report from the SCC Highways and the work could then be undertaken, if the Committee approved, with a possible 10% increase on the quotation of £595 due to the stipulation that hand machinery could only be used, which may increase the labour time.

**Resolved** that the quotation be approved with a possible 10% increase on the quotation of  $\pounds 595$  due to the stipulation that hand machinery could only be used, which may increase the labour time and SCC approval.

Cllr Mrs Petula Hughes entered the meeting at 8.00 pm

#### 1200. CHRISTMAS 2016

[a] A quotation was received and considered from Turnocks to have an 'artificial' Christmas Tree' on Crown Bridge Island.

**Resolved** that Councillors agreed to keep a traditional tree for the island and the PA to source alternative suppliers and this item be included on the July agenda for further consideration

[b] Consideration was given to a request from the SSC Community Safety Officer to remove some of the Christmas Trees in Market Street which obscures the CCTV Camera.

Councillors felt that the camera still appears to catch Images and the Christmas Trees are only in place for a short period each year so SSC be asked what other arrangements they could make during this time.

**Resolved** that SSC be advised of the above.

## 1201. BEST KEPT VILLAGE 2016

The Chairman advised that there had been two meetings with the Chairman of the Civic Society and the map had been compiled by Cllr Stonehouse ands the forms now submitted.

#### 1202. FRANCIS GREEN LANE ALLOTMENTS

Consideration was given to a quotation from Penkridge Fencing to have a new Gate and posts for the entrance to the above at a cost of £900 - £1,100 depending on the type of wood.

Councillors asked if TFM would supply and sponsor a field gate and posts to the site.

**<u>Resolved</u>** that TFM be asked if they would supply and sponsor a field gate and posts to entrance of the above site.

## 1203. RE-PLANTING A449

Consideration was given to the suggested re-planting for the two corners of the A449 at Boscomoor Lane and Bungham Lane further to a site meeting with the Council's Contractor. The Chairman advised that he had a site visit with the Contractor and PA on 23<sup>rd</sup> March to discuss the above sites now all the ivy had been removed.

The Chairman asked the Committee if they now wished to progress the updated quotation from Brocton Nurseries to plant both beds at a cost of £650 per bed for approximately 100 plants per bed of Cotoneaster, Lavatera, Buddleia and Lavender together with an additional quote for £200 per bed to cover with a membrane, mulch and ornamental bark.

**<u>Resolved</u>** that the above quotation and planting be undertaken and approved by the Committee.

# 1204. <u>BUS SHELTERS REVIEW - GAILEY</u>

The Chairman advised that whilst Councillors undertook the walk of the A449 it was noticeable that the wooden Bus Shelter in-between the Spread Eagle and Dobbies required some attention with ivy growing through from the back.

**Resolved** that both the Spread Eagle and Dobbies be asked if they would contribute towards the cost of a new Shelter.

### 1205. VILLAGE TOILETS

It was noted that the above would be closed at 3.00 pm on Sundays for a one month trial to commence at the beginning of April due to petty vandalism.

**<u>Resolved</u>** that a sign be placed in the Toilet Noticeboard advising that CCTV was in operation due to vandalism.

The Chairman updated the Councillors on the previous Library visit with members of SCC, Civic Society and Friends of Penkridge Library. He said that it had appeared some work had been undertaken inside the building to repair the kitchen area and tidy up other parts of the building. He also said that SCC had a little pot of money that they could use towards a Feasibility Study of the building and they would undertake the necessary steps to put this request forward.

Councillors asked that the Library be an item on future Recreation and Amenities agendas where regular updates can be given.
