## Part I - Public Session

#### 3456. APOLOGIES

Apologies were received from Cllrs Craddock, Mrs Ford and Minshall.

#### 3457. PERSONALIA AND EVENTS

The above was received for March 2017.

#### 3458. DECLARATIONS OF INTEREST

#### 3459. DISCLOSABLE PECUNIARY INTEREST (DPI)

There were no DPI's received.

#### 3460. PUBLIC PARTICIPATION

Cllr Eastwood spoke on behalf of Mr Steve Gregg who lived on Cherrybrook and was present at the meeting. Cllr Eastwood advised that there were 3 large conifer trees at the rear of the Cherrybrook Open Space which had never been maintained and stood at approximately 50 ft. He said that Mr Gregg and his neighbours were concerned firstly with the safety aspect of the trees due to their height/mass and secondly the murmurings of the starlings which had also being creating a terrible mess to houses and cars. Cllr Eastwood asked, as the trees were part of the open space leased by the Parish from South Staffordshire Council, if they would consider having the trees trimmed to alleviate the problem.

The Chairman asked if the PA would speak to the SSC Landscape Team to see what they advised.

Cllr Eastwood said he had also been approached by a resident of Haling Road with regard to the planters outside of St Michael's First School, he said the planters had been relocated from their original position and was now blocking the footpath. Cllr Mrs Petula Hughes said she had also been approached by a resident of Haling Road who was partially sighted and as the planters were a dark colour they were hard to see at night and the resident had fallen over them.

The Chairman asked the PA if she could contact both the SCC Cllr and SCC Highways to ask that they review the positioning of the Planters.

### 3460. PUBLIC PARTICIPATION [Cont'd]

Cllr Kelly said he had been approached by a resident asking why the Council no longer produced the PPC News and could this be re-instated.

The Chairman said the PA was waiting for a reply form the Rector and Parochial Church Council if this could once again be included with the Fishnet.

Cllr Miss Burns asked if she could talk on behalf of the Stop The Gailey Freight Hub group and appeal to Councillors and Parishioners to help prevent the Freight Hub going ahead. She advised that the proposed location would take away the Green Belt and everyone should be pro-active and help protect the environment. There was a location for the Freight Hub in Brown Fields sites, which had the backing of the residents, as it would create much needed jobs. Cllr Miss Burns said that the group had the backing of Jeremy Lefroy MP and Gavin Williams MP. Mr Williams was holding a public meeting on Friday 21st April at the Coven Memorial Hall and recommended that everyone should attend. Both MPs were also planning to undertake a leaflet drop through all the doors in Penkridge and its immediate surroundings. The Chairman advised that the Council had offered the Haling Dene Centre as a possible
