## Litter & Dog Waste Bins

South Staffordshire Council have provided over 900 bins located around South Staffs to dispose of litter and dog waste.

Penkridge has seen an increase in Litter and Dog Waste over the past few months. Can we remind Parishioners to use the litter bins and Dog Owners to pick up their dog waste and use the bins provided.

The Dogs (Fouling of Land) Act 1996 requires people to pick up after their dogs and failure to do this may result in the issue of a fixed penalty notice of £50. If this is not paid then you may be taken to court where the fine can be up to £1,000. Most public areas within Penkridge, including most footpaths, are covered by the Act.

To request the removal of dog fouling from public land or to report somebody that you suspect is allowing a dog to foul and then not clearing up the waste, please use South Staffs Council's online Form. Alternatively, contact Customer Services on 01902 696000.

## Fly Tipping

It is an offence under the Environmental Protection Act 1990 for any person to fly tip rubbish on any land in the open air. South Staffs Council take fly tipping very seriously and where there is sufficient evidence they will seek to prosecute offenders. If found guilty of the offence at Crown Court the offender may be liable for a fine of up to £50,000 and up to five years imprisonment.

We will not remove fly tipping on private land but may take action if there is sufficient evidence.
